BELOW ARE THE RESULTS OF THE 2024 SEPO ELECTION:

The SEPO Board of Directors Positions they now hold

The tallies of the Ballots submitted for the three (3) Covenants proposals.

The results of the 2024 SEPO Election were presented during the 3 PM portion of the Annual meeting on Feb 20, 2024. Each of the three Board Candidates, Tracy Wagner, Randy Davis and Scott Kronshage were elected to fill the three open Board positions. Immediately after the Annual meeting the 2024 Board members held the Required Board meeting and determined which members would fill which Board positions. The first document below depicts those decisions. It is also available on the Sunshine Website (https://www.sunshinecountryclub.com/directories).

After that document, you will see the proposed Covenants descriptions and the tallies of the Ballots submitted and 'not' submitted' for all three proposals. To change a Covenant requires 205 'approvals' of the 306 possible ballots. As was emphasized before the election, if you did not submit a ballot for a Covenants proposal, it is an automatic 'DISAPPROVE' vote.

ARTICLE VI: USE RESTRICTIONS - SECTION 6.1 SENIOR CITIZEN RESIDENTIAL USE (AGE)

(Current language is)

No one under the age of 18 years shall be allowed to reside in any residence located within the subdivision. This shall include children born to or adopted by residents.

(Proposed language showing addition)

No one under the age of <u>18forty (40)</u> years shall be allowed to reside in any residence located within the subdivision except for a person who, of necessity, is providing caregiving or who needs caregiving. In this event an application must be made to the Board of Directors prior to such residence and will be considered on a case-by-case basis. The decision of the Board of Directors shall be final for such exception. This age restriction shall include children born to or adopted by residents and any immediate family.

| (Final language would be) No one under the age of forty (40) years shall be allowed to reside in any residence located within the subdivision except for a person who, of necessity, is providing caregiving or who needs caregiving. In this event an application must be made to the Board of Directors prior to such residence and will be considered or a case-by-case basis. SSCCE Men's League Rules of play

Fairways

Fairways are defined as any portion of the course not considered to be out of Bounds", a "Hazard" (sand or water), or the "Green".

- 1. Ball may be moved 12 inches on the fairways at any time (no closer to the pin).
- 2. Ball may be moved off of bare ground (no closer to the pin).
- 3. Ball may be "Picked, Cleaned and Placed" at any time except in a hazard or trap.
- 4. An unplayable ball may be moved 2 club lengths from the following: (no closer to the pin).
 - A. In bounds but next to "Out of Bounds" marker or wall.
 - B. Ground under repair.
 - C. Short of going into the water or where Water Hazard impedes stance.
 - D. Man-made objects.

Out of Bounds and Water Hazards

Course boundaries are indicated by white post and/or low cement or wood barriers. A ball must be completely beyond the boundary line to be considered "Out of Bounds". Water hazards boundaries are considered to be inside vertical face, and it's vertical extension, of the cement sand bag walls of the hazard. A ball hitting the vertical face of the sand bag wall and falling into the water without touching ground beyond the vertical extension is deemed to be in the hazard and not be the point at which it entered the hazard. A ball lodging in the wall (space between cement sand bags) of a water hazard is deemed to be in the hazard. Drop point for lodged ball will be where it last crossed the hazard boundary before lodging.

- 1. All balls "Out of Bounds" or in a "Water Hazard" will be played from the point they crossed the "Out of Bounds" boundary or "Water Hazard" boundary. The ball will be dropped no more than 2 club lengths from the point where it crossed the boundary line (no closer to the pin) (1penalty stroke). If the shot that enters "Out of Bounds" or a "Water Hazard", from a teed ball, the player has the option to re-tee and incur the standard "Stroke and Distance" penalty. ie. Player hits ball OB or in the water, re-tees and lands in the "fairway". The player now lies 3. LEAGUE DOES NOT USE DROP ZONES.
- 2. Exception to above rule. If a ball is hit from the 7th tee into the "Out of Bounds" behind the 6th green or if a house obstructs the view to the 7th green, the ball may be

put into play by dropping in front of the 7th tee box with a one stroke penalty or may be reteed with utilizing the standard "Stroke and Distance" rule.

Sand Traps

- 1. Grounding club to improve your lie or a practice swing that touches the sand is a 1 stroke penalty. Except as indicated in
- 2. Picking up your ball (1 stroke penalty).
- 3. A ball may be picked up and marked when 2 balls are side-by-side in a trap. The ball may not be cleaned and must be placed as close as possible to the original position and condition of the lie after the first player hit (no penalty)

Casual Water

- "Casual Water" is defined as any water pooling on the course in any place nor designed as a "Water Hazard". Pooling can be considered to occur if water is evident around the sole of your shoe when you stand in a wet spot. When in doubt, consult with playing partners. If doubt still exist, play the original and a provisional and consult with the tournament director when the round is completed.
- 2. When in "Casual Water", the ball may be moved back or laterally to gain complete relief no closer to the pin). No penalty.

Bridges

- 1. All bridges will be treated as cart paths.
- 2. If a ball comes to rest on a bridge the ball may be played as it lies or it may be dropped at the closest point of relief, no closer to the hole, and be played without penalty.

Tee Box

The "Tee Box" is defined as the area on the teeing ground between the tee markers. The "Tee Box" extends from the front edge of the tee markers to a point two club lengths behind the front edge of the tee markers. Only the ball must be within the tee box when teeing off. If the ball is outside the Tee Box when put into play a one stroke penalty will be assessed and the ball must be re-teed and put into play from the Tee Box.

- 1. When teeing off, a tee must be used.
- 2. All whiffs are counted. A whiff is when you address the ball, swing and miss.

3. If a ball does not clear the tee ground, the ball will be played as it lies or opt for re-teeing with a 1 stroke penalty.

Greens

The "Green" is that area of closely mowed grass surrounding the cup. The "Fringe is the slightly longer grass surrounding the green. For our purposes, the "Fringe shall be treated as "Fairway".

- 1. When marking a ball, the marker should be placed behind the ball. If the ball is in the line of another player's putt the marker may be moved to the side as far as deemed necessary by the player whose line is infringed. The ball will be returned to its original position before putting. Failure to return to return the ball to the original position will result in a one stroke penalty. If the penalty is assessed for failure to putt from the original position, the ball must be placed in the original positioned and putted.
- 2. A two stroke penalty will be assessed if, while putting on the green, you play from another player's marker
- 3. A one stroke penalty is assessed for your ball striking another player's ball that is lying on the "Green" while putting your ball from any spot on the "Green".
- 4. A two stroke penalty is assessed for hitting a club or flagstick lying on the "Green".
- 5. The flag may be in or out when chipping or putting from the fringe.
- 6. If your ball is on the "Green" and the hole cannot be clearly seen, you may ask to have it attended. The flag must be released or removed before the ball gets to the hole. If the ball hits the pin while being tended it's a 1 stroke penalty.
- 7. Once a player starts putting he has control of the green and may putt out if he so desires.
- 8. All putts must be holed. No gimmies! Failure to complete the hole will result in disqualification.

Other Rules or Situations Not Covered by Above Rules:

USGA rules will deem to be in place when situation or rulings not covered by the mentioned rules occur. In all situations the Rules Committee, made of the League Officers, or their designee(s), will make the final ruling when disputes or rules questions occur. If, while playing, a situation occurs that the players are unsure of, play a provisional ball with deemed relief as well as the original ball as it lies and the Rules Committee will make a determination of the correct sore for the hole after the round.

Common Golf Courtesy

- 1. Exit the "Green" as soon as all golfers have finished putting.
- 2. Record your scores on the next tee.
- 3. Do not drive or park carts within 15 feet of the fringe of the "Green".
- 4. REPAIR ALL BALL MARKS ON "GREEN".
- 5. Repair and replace all divots on the "Tee Box" or fill them with available sand.
- 6. Share carts when possible!
- 7. Rake sand traps after use.
- 8. Do Not run golf carts through casual water.
- 9. No practice chipping to the "Greens".
- 10. Do not spend excessive time looking for a lost ball (3 minutes should be Maximum limit).
- 11. No loud noises while a golfer is taking a shot.
- 12. Golfers 90 years or older may hit from the women's "Tee Box" if they desire.
- 13. Do not drive golf carts between sand traps and "Greens".
- 14. Practice putting only on the PRACTICE GREEN.
- 15. Be respectful of workers. Wait till they have completed their task, have waved you up, or are aware of you hitting at them.

This article will update you on developments in the SEPO library during the past year. In addition, I give you a recommendation for an author with whom you might not be familiar but whose works you might enjoy reading.

First, thanks very much to the Women's Club, whose members provided reimbursement for some of the cost of adding purchased books to our collection. In addition, they voted to have a cash donation box placed in the library and arranged for it to be attached to the book cart. We have already received a donation, which has been used to help purchase rolls of tape to be used in the labeling machine. Speaking of the book cart, Vicky Krueger-Leroy, then the Women's Club President, spearheaded the effort to donate most of our hymnals, which were no longer being used, to a church and move the cart the hymnals were on to the library. John Chajek attached new wheels to the cart, and it's now where we place books we return or donate to the library. It is working out very well.

OK ... on to information about additions to the library. I'll start with general fiction authors, some of whom may have been unknown to you until now. Among others, we have added books by:

- Isabel Allende: we have 6 books by this award-winning Chilean-American author, who
 may be the world's most widely-read Spanish-language author (our books are in English).
 She has won literary awards in 9 different countries, including the US Presidential Medal
 of Freedom.
- Jean M. Auel: we have at least 5 works by this best-selling author of the Earth's Children series, which is set in prehistoric Europe and explores human activities during this time.
- Jennifer Chiaverini: we have 14 of the 22 books in her Elm Creek Quilts series. Quiltlovers: these books are for you!
- Jan Karon: we have 9 of her 14 Mitford Years books.
- Tim LaHaye & Jerry B. Jenkins: we have 14 of the 16 books in their Left Behind series.
- Liane Moriarty: we have 6 of her 12 novels, including Big Little Lies.
- Lisa See & Amy Tan: both of these women write primarily about Chinese and Chinese-American characters and culture. We have 3 See books and 6 books by Tan, including Joy Luck Club.

We have added quite a few mystery and suspense books. Among the authors who I did not mention in last year's update are:

- David Baldacci: we have at least 28 of his 46 suspense & legal thrillers.
- Steve Berry: we now have 9 of his books, which are action-packed and link real historical events/places (such as WWI/Hitler and the tomb of China's First Emperor) with modern-day crises.
- Sophie Hannah: we have 5 of her 12 Zailer & Waterhouse psychological crime fiction novels and 2 of her 5 new Hercule Poirot mysteries. She has been authorized by the Agatha Christie family & estate to continue the Poirot series.

- Camilla Lackberg: we have 4 books by this award-winning Swedish crime writer, who has been described as "the rock star of Nordic noir."
- Stieg Larsson: we have the first three of this Swedish writer's Millennium books. You may have heard of these books, whose titles start with "The Girl With' or 'The Girl Who."
- Anne Perry: we have 15 books by this writer of historical detective fiction.
- We also have added books by, among others: Harlan Coben (have 11 books), Michael Connelly (over 2 dozen books), Clive Cussler (over 2 dozen), Elizabeth George (10/21 Inspector Lynley books), Stephen King (5 books), P. D. James (all the Adam Dalghiesh mysteries), Jack Higgins (13 books), Jonathan Kellerman, Robert Ludlum, Steve Martini, and Perri O'Shaughnessy.

For Western fans: we have recently received two anthologies of Western stories: *A Century of Great Western Stories* (edited by J. Jakes) and *Boot Hill* (edited by R. Randisi). All of the stories in the latter book are related to Dodge City, and all for one were written for this book. We have 4 of Craig Johnson's Walt Longmire books. I have purchased several books that are included in online lists of best Western novels: *Little Big Man* (Thomas Berger), *The Virginian* (Owen Wister), *Riders of the Purple Sage* (Zane Grey), and *True Grit* (Charles Portis). We also have added a Western published in 1903: *The Log of a Cowboy* by Andy Adams.

OK, romance lovers, we have not left you out.

- Lorraine Heath: we have 4 of the 5 books in her Scoundrels of St. James series.
- Sarah MacLean: we have all of the books in her Scandel & Scoundrels and The Rules of Scoundrels series and most of the books in her Bareknuckle Bastards and Love by Numbers series.
- Karen Kingsbury: this Christian-centered fiction writer includes romance in her novels. We have all of the books in her Firstborn and Redemption series, 3 of 4 in the Bailey Flanigan series, 2/4 in her Sunrise series, and 3/10 of her Baxter Family series.
- Beverly Lewis: we have about 8 of her Christian-centered books, which are set in Amish communities.
- We have added to our collections of books by, among others, Danielle Steel, Norah Roberts/J. D. Robb, Rae Anne Thayne, Kat Martin, and Linda Lael Miller.

SEPO residents have added several science fiction and fantasy books this past year.

- Robert A. Heinlein: we have 5 of his science fiction books.
- Isaac Asimov: we have 3 books by this biochemistry professor who is one of the best-known 20th-century science fiction writers.
- Stephanie Meyer: we have 3 of the 5 books in the Twilight series and one of her standalone novels.
- K. E. Mills: we have all of his Rogue Agent fantasy books.
- Neal Shusterman: we have 4 of his 6 Unwind Dystology books.

We have purchased several used books about World War II and Vietnam that have been listed on "best books" lists: *Dereliction of Duty* (H.R. McMaster), *We Were Soldiers Once ... and Young*

(G. Moore & J.L. Galloway), When Heaven and Earth Changed Places (L.L. Hayship), Countdown 1945 (M. Weiss), Band of Brothers and D-Day (S.E.Ambrose), Ghost Soldiers (H. Sides), and The Monuments Men (R.M. Edsel).

We have added several books about golfers and strategies for improving your golf game. We have increased our holdings of poetry books from 2 to over 10.

We have made some minor organizational changes in the library. We have added two bins of anthologies (mysteries and romances), which are located in the area with authors whose last names start with L. The poetry books are in magazine holders that have been moved to the shelf above the King/Kingsbury books).

Author Recommendation:

Alexander McCall Smith

If you are looking for an author who writes gentle, thoughtful, compassionate, philosophical, literate, wryly humorous, sometimes whimsical books with a strong sense of place, I recommend Alexander McCall Smith. This African-born Scottish writer (and attorney) "... sees his characters and their world, fully and tenderly. And that makes for a book that is as comforting to sink into as a well-worn armchair" (M. Moss, NY Journal of Books). R. Strauss of publishersweekly.com writes of Smith's work: "The drama may be slight, but what pulls the reader in is the good natures of (almost) all the characters and McCall Smith's uncanny ability to see their world as they do, and to render their worries, pleasures, and musings with charm, grace, and geniality." I couldn't have said it better myself.

We have 63 of Smith's books! He has written several series of adult books, as well as standalone novels and many children's books. I'll describe three of my favorite of his series.

- The No. 1 Ladies' Detective Agency: this is his best-known book series. The stories take place in Botswana, where Precious Ramotswa starts the first Botswanan detective agency owned and operated by a woman. She addresses everyday-life problems rather than violent crimes such as murder. If you want to try out this series, the first book has the same name as the series.
- Isabel Dalhousie series: there stories take place in Edinburgh, Scotland. The lead character edits a philosophy journal and applies her deductive gifts and ethical framework to resolving issues brought to her by others or that she stumbles upon herself. There's also an interesting and engaging love story. The first book in this series is entitled *The Sunday Philosophy Club*.
- 44 Scotland Street series: these books follow the increasingly intertwined lives of several residents of an Edinburgh neighborhood. The first book in the series has the same name as the series.

In closing, I hope this update encourages you to explore new acquisitions by authors you have read before and to try out authors who are new to you. Thank you very much for continuing to contribute books to the library, allowing us to refresh our holdings every week. Happy reading to you all!!
