

MINUTES OF WOMEN'S CLUB MEETING
SUNSHINE COUNTRY CLUB ESTATES
OCTOBER 21, 2022

The meeting was called to order at 9 A.M. by President Vicky Krueger.

New resident, Vicki Carroll, talked about Valley Voices, a retiree choir of which she is a member. She stated they would be willing to perform for Sunshine, asking only for a donation. OFFICERS REPORTS:

COMMITTEE REPORTS;

Judy Stone, Activity Director, asked for a Chair for the Christmas Dinner. Lenore Combs volunteered. Nancy Steele still needs four or five performers for the Christmas Skit.

A Chair is also needed for the Super Bowl Party.

Pam Davis and Lenore Combs agreed to check into coordinating a Halloween Parade.

Judy advised that additional functions can still be added to the calendar if dates are available. Discussion was also made on how to advise the community of any off-site activities.

Judy Stone made a thorough audit of the Treasurer's Books and found no discrepancies.

She did suggest that when dealing with cash, it is always advisable for two people to be present.

Lenore Combs reported on Neighborhood Watch. We are now into a two-patrol season; 8:30 and 10:30. Volunteers are always needed and for block captains. Lenore also reported that the Finger Lickin' Chicken fundraiser may be held sometime in January.

OLD BUSINESS:

A vote was made by paper ballot to decide if the Women's Club should give Lost Ball Rescue an additional \$672.21 which was the amount the Women's Club advanced to purchase food for the function. Votes were counted and the majority voted "no".

Discussion was made regarding the televisions in Retzlaff Hall. It was decided no larger ones were needed.

If members wish to do Resident Pictures, Deb Robins has agreed to take them and update the website.

NEW BUSINESS:

Judy Stone has agreed to fill the position of Vice President. She will retain the position of Activities Director at this time.

SEPO has asked the Women's Club to help with treats for Manny's 40-year anniversary with SEPO that will be acknowledged at the November residents meeting and for the employee's recognition at the December meeting. It was decided that volunteers would be needed to bake cookies.

Treats are also needed for Veteran's Day on November 11th. It was decided a cake would be purchased.
