The 2021 Board will hold the Annual Shareholders Meeting on February 15, 2022. There will be two meetings that day. The 1 PM meeting is strictly to determine if there is a quorum to proceed with counting the ballots received. The 3 PM meeting will include reporting on votes for three Board Director positions and acceptance or rejection of several proposed amendments to our Bylaws and Covenants. The Board committed a lot of time, energy, effort and discussion associated with the proposed amendments. It is important that every homeowner votes on these critical issues.

Everyone attending this meeting "in person", by their presence, acknowledges potential exposure to COVID – 19. Each person is responsible for his/her own choice as it relates to attending NW-CERT meetings.

Officer Rebecca Cruz is our newly assigned HPD NW liaison and she will be here at the February meeting (21 Feb 3pm). They (our District Officers) may go over the new Texas Golf Cart laws, now referred to as low speed vehicles. It would be great if some of the owners of these vehicles would be present to share their 2 Cents.

Recent happenings and reports:

Suspicious vehicle

1. It was reported - a suspicious vehicle (dark color) parked by the Gazebo about 4:30am last week. (Was it the paper delivery?????)

What was reported to me was a concern about strange cars driving around......; ? a person walking thru the homes to get to the street into SCCE. Again not much info for a report to justify an "area to patrol" but HPD said they would check us out anyway and Encore too. As well, they will pay a visit to the Carnies on the corner to inform them this is private property.
- 3. Wednesday, it was reported to Valerie by a resident that a business vehicle was in here driving around soliciting for security systems.
- 4. There is a NO SOLICITING sign at our front entrance and an offense can be treated with a fine etc. Again, if you wish to report a soliciting issue, I need more general info if possible who what where when and a description of the vehicle make model distinctive markings etc. I did call Brinks Security but to no avail.
